Tucker ((208) 736-0041) for the Idaho Power Company, and Steven W. Strack ((208) 334-2690) for the State of Idaho. On February 11, 2000, the Federal Claims Coalition filed *Federal Claims Coalition's Response to Nez Perce Tribe's Motion for Briefing Schedule* objecting to the proposed scheduling order. While the Court acknowledges the concerns expressed by the Federal Claims Coalition, in an effort to maintain the SRBA calendar, which is presently effected by the pending motions filed by the United States and the Nez Perce Tribe, and in fairness to all parties, the matter needs to be heard as scheduled.
