Case No. 49576	ORDER OF PARTIAL DECREE FOR GENERAL PROVISION IN BASIN 93

On March 27, 2014, the Director of the Idaho Department of Water Resources filed a Director's Report for Basin 93, which included a recommendation for a general provision. Objections to the recommendation were filed by the City of Coeur d'Alene and the State of Idaho. The objections were resolved by the filing of a Standard Form 5 on November 1, 2019. In the Standard Form 5, the parties agreed that there should be no general provisions in Basin 93. On February 25, 2020, the Special Master entered a Special Master's Report and Recommendation, recommending that there shall be no general provisions in Basin 93 consistent with the Standard Form 5. No Challenges were filed to the Special Master's Report and Recommendation and the time for filing Challenges has now expired.

Pursuant to I.R.C.P. 53(j), this Court has reviewed the findings of fact and conclusions of law contained in the *Special Master's Report and Recommendation* and wholly adopts them as its own.

Therefore, IT IS ORDERED that there shall be no general provisions in Basin 93 as set forth in the attached.


