

THEREFORE, BASED ON THE FOREGOING, THE FOLLOWING ARE HEREBY ORDERED:

1. The stipulated motion to extend the stay is hereby granted.
2. All proceedings in the above-captioned matter are stayed until November 1, 2024.
3. On November 1, 2024, the parties shall either (1) stipulate to dismissal of this action, or (2) file a notice with the Court asking the Court to move forward with considering the pending petition for rehearing.
