NOTICE IS GIVEN that hearing on the *Motion to File Late Notice of Claim* is set for **Tuesday, June 18, 2019, at 1:30 p.m.** (<u>Pacific Time</u>), at the Idaho Water Adjudications **District Court, 253 - 3rd Avenue North, Twin Falls, Idaho.** It is not mandatory for you to appear in person at this hearing. Parties may participate by telephone by dialing the number **1-720-279-0026** and when prompted entering code **786692, followed by the # sign**. Should you experience difficulty connecting to the conference call or experience a disconnect during the proceedings, please hang up and call the court clerk at 208-736-3011, for further instructions.

NOTE: It is customary for multiple hearings to be scheduled for this time slot. You will need to call in promptly at 1:30 p.m. (Pacific Time). Momentarily, the court clerk will come on the line and provide further instruction. In an effort to proceed as quickly as possible and minimize any confusion, please wait to identify yourself until Judge Wildman calls your water right number. At that time, he will inquire as to who is participating in that particular hearing. Once your hearing is completed, you are free to hang up your phone.

The courtroom is equipped with a very sensitive sound system and can pick up any whispering, paper shuffling and background noise. As you are waiting for your hearing, we request you remain as quiet as possible in order for the court reporter to accurately record the

proceedings. When at all possible, please avoid calling in using a cell phone and the use of the "speaker" feature on your handset phone is prohibited, as these two uses can result in interference with the sound system.

Failure to appear at the hearing, either in person or by telephone, may result in <u>dismissal</u> of your *Motion to File Late Notice of Claim*.
