I. FINDINGS OF FACT

A notice of claim was filed for this water right pursuant to I.C. § 42-1409. The Director of the State of Idaho Department of Water Resources examined the water system for this reporting area. The *Director's Report* contained a recommendation for the elements of this water right.

An *Objection* was filed on January 10, 2022 by the United States, as trustee on behalf of the Nez Perce Tribe. An Initial Hearing was held on September 22, 2022. A *Motion to Dismiss Claim* was filed on January 24, 2023. A hearing on the *Motion* was held on February 8, 2023. There was no opposition to the *Motion*.

The Court granted the Motion. Order Granting Motion to Withdraw Claim. (February 21, 2023)


II. CONCLUSIONS OF LAW


