Status Conferences were held on March 27, 2024 and April 3, 2024. At the hearings, the parties discussed how to move forward on settlement discussions in both the Springs and Fountains subcases and the Instream Flow subcases.

The court recognizes that formal litigation of subcases in the Palouse River Basin Adjudication may impose a burden on parties. Settlement conferences can provide an opportunity to settle subcases and avoid a trial. These conferences can help open lines of communication, clarify issues, reveal the strengths and weaknesses of each party’s legal position, identify areas of agreement and generate options for a resolution of the dispute.

The parties have done significant work on factual issues and will provide a summary at the first settlement conference. The parties asked that the settlement conference be conducted on April 30, 2024 by Zoom. The first settlement conference will provide background information to the settlement moderator and will also focus on creating a structure for future settlement conferences. It is anticipated that there will be multiple settlement conferences.
