As a result, the Stipulated Motion requests that the Protective Order "be extended until September 1, 2024." Counsel for the Tribe represents that the other parties to this consolidated subcase do not oppose the Stipulated Motion. Therefore, in an exercise of its discretion, the Court will grant the Stipulated Motion on the basis it is unopposed.

THEREFORE, BASED ON THE FOREGOING, THE FOLLOWING ARE HEREBY ORDERED:

- 1. The Stipulated Motion is hereby granted.
- 2. The Protective Order entered in this consolidated subcase on June 15, 2021, is hereby extended until September 1, 2024, as requested by the Stipulated Motion.
