A notice of claim was filed for the above-captioned water right pursuant to I.C. § 42-1409. The Director of the State of Idaho Department of Water Resources (IDWR) examined the water system for this reporting area. The *Director's Report* contained a recommendation for the elements of this water right.

On July 15, 2019, the claimants of the water right, through their attorney Michael P. Lawrence, filed on objection to the *Director's Report*. Responses were filed by Daniel Barkley, Melissa Stocking, and Kathryn M. Spackman, though their attorney Norman M. Semanko. On July 11, 2024, the parties filed a *Standard Form 5 – Stipulated Elements of a Water Right* which resolved the objection.

Therefore, based on the file and record herein and pursuant to the *Standard Form 5*, IT IS RECOMMENDED that water right 95-02138 be decreed with the elements as set forth in the attached *Recommendation for Partial Decree Pursuant to I.R.C.P. 54(b)*.


RULE 54(b) CERTIFICATE
