It is not mandatory for you to appear in person at this hearing. Parties shall participate by the remote meeting application ZOOM. The instructions for ZOOM are attached to this Notice. Should you experience difficulty connecting to the hearing or need any assistance, contact the court clerk at 208-736-3011.

NOTE: It is customary for multiple hearings to be scheduled for this time slot. You will need to initiate ZOOM by 1:30 p.m. (Pacific Time). You will be placed in a Waiting Room. A message will appear "Please wait, the meeting host will let you in soon." When court begins, you will be brought into the meeting from the Waiting Room.

In an effort to proceed as quickly as possible and minimize any confusion, please wait to identify yourself until Judge Wildman calls your water right number. At that time, he will inquire as to who is participating in that particular hearing. Once your hearing is completed, you may disconnect.

The courtroom is equipped with a very sensitive sound system and can pick up any whispering, paper shuffling and background noise. As you are waiting for your hearing, we request you remain as quiet as possible in order for the court reporter to accurately record the proceedings.

<u>Failure to appear at the hearing</u>, either in person, or using a telephone or online with a video or audio connection <u>may result in a dismissal</u> of your *Motion to File Late Notice of Claim*.

1. How to join the meeting by telephone

- When prompted, enter the meeting password provided above, followed by #.

2. How to join the meeting online

- In your browser enter the link https://www.zoom.us/join

- Follow the instructions on the screen to either download and install the Zoom client, or to join the meeting via your web browser.
- When prompted, enter the meeting password provided above.
- Once the connection is made, you will be placed in a Waiting Room. A message will appear "Please wait, the meeting host will let you in soon."
- When court begins, you will be brought into the meeting from the Waiting Room.

3. Video (when joining online)

• Start your video by clicking **Start Video**, located in the lower-left corner of the window.

4. Audio

- Your sound will be on mute upon entry.
- Remain muted unless you are asked to speak to the court. Please be sure you have no background noise while speaking. You may be muted or removed from the hearing if causing a disruption.
- To unmute yourself, click the **Unmute** button, located in the lower-left corner of the window.
- If joining only by telephone, press *6 to toggle between unmute/mute.
