DESCRIPTIVE SUMMARY

This is a Director's Report of Deferred *De Minimis* Domestic and/or Stock Water Use submitted by the Director of the Idaho Department of Water Resources (IDWR).

INTRODUCTION

A Motion for Determination of Deferred *De Minimis* Domestic and/or Stock Water Use (Motion), as well as a Notice of Claim to Water Right, was received by the Court on January 31, 2024, for water right claim no. 63-35068. The Claimant published notice of the Motion, and the Director has now completed his examination of the water right claim. The examination was conducted by Scott Luvaas, Senior Water Resource Agent, Adjudication Section, on behalf of the Director. The materials used in and results of the examination of the elements of water right claim no. 63-35068 are discussed below.

DISCUSSION

Ownership

Claim 63-35068 was filed in the name of Edward A Rose Jr. However, Ada County parcel data indicates that the parcel is owned by the *Rose Family Trust*. On September 19, 2024, IDWR received an amended claim that changed ownership of claim 63-35068 to the *Rose Family Trust*.

Priority Date

The claimed priority date is December 1, 1998. Ada County parcel data shows a built date of 1998. The priority date is recommended as December 1, 1998, consistent with available evidence.

Point of Diversion

The claimed point of diversion is located on Ada County parcel R5782850100 which

according to available Ada County parcel data, is owned by the Rose Family Trust. The claim identifies the point of diversion location using GPS coordinates. The coordinates place the point of diversion location in Township 05 North, Range 01 West, Section 31, SW¼NE¼, which is on parcel R5782850100. The point of diversion location is recommended as Township 05 North, Range 01 West, Section 31, SW¼NE¼.

Source

The source claimed is "ground water". Item 5 on the claim describes the source as a "Domestic well". The source for water diverted from a well is described as ground water. The source is recommended as claimed.

Place of Use

The claimed place of use is located on Ada County parcel R5782850100. The location of the place of use is described as Township 05 North, Range 01 West, Section 31, SW¹/₄NE¹/₄. According to the Ada County parcel data, Rose Family Trust owns the property described as the claimed place of use. The place of use is recommended as claimed based on Ada County parcel data.

Purpose of Use and Period of Use

The claimed purpose of use is for domestic use for one (1) home as well as stockwater use for 10 horses. Evidence of a domestic structure and a secondary structure are visible on available aerial imagery. The purpose of use is recommended as claimed. A year-round season of use for domestic and stockwater use is generally recommended if claimed. The season of use for domestic and stockwater use is recommended as claimed.

Quantity

The claimed quantity is 0.24 cubic feet per second ("cfs") for domestic use and 0.02 cfs

for stockwater use. The standard quantity for domestic use is 0.04 cfs¹ and the standard quantity for stockwater use for 10 head is 0.02 cfs². No evidence is available to support the claimed quantity. The quantity is recommended as 0.04 cfs for domestic and 0.02 cfs for stockwater, with a total quantity of 0.06 cfs, based on the information above.

CONCLUSION

There is sufficient evidence to recommend water right claim no. 63-35068. Pursuant to Judge Wildman's *Order Amending Procedures in the SRBA for Adjudication of Deferred De Minimis Stockwater Claims*, dated *October 17*, 2017, the Director submits this Director's Report of Deferred *De Minimis* Domestic and/or Stock Water Use, Claim No. 63-35068, which includes the recommendation of deferred *de minimis* water right no. 63-35068.
