DESCRIPTIVE SUMMARY

This is a Director's Report of Deferred *De Minimis* Domestic and/or Stock Water Use submitted by the Director of the Idaho Department of Water Resources (IDWR).

INTRODUCTION

A Motion for Determination of Deferred *De Minimis* Domestic and/or Stock Water Use (Motion), as well as a Notice of Claim to Water Right, was received by the Court on February 15, 2024, for water right claim no. 63-35519. The Claimant published notice of the Motion, and the Director has now completed his examination of the water right claim. The examination was conducted by Scott Luvaas, Senior Water Resource Agent, Adjudication Section, on behalf of the Director. The materials used in and results of the examination of the elements of water right claim no. 63-35519 are discussed below.

DISCUSSION

Ownership

Claim 63-35519 was filed in the name of Steve and Joanne Love. However, Ada County parcel data indicates that the parcel is owned by the *Steve & Joanne Love Revocable Trust*. On August 27, 2024, IDWR sent the claimants an amended claim to update ownership on the claim. On September 5, 2024, IDWR received an amended claim that changed ownership of claim 63-35519 to the *Steve and Joanne Love Revocable Trust*.

Priority Date

The claimed priority date is February 5, 1996. Ada County parcel data shows a built date of 1996. Well Driller's Report (Drilling Permit No. 63-95-W-0906-000, Well ID: 298289) shows a well was drilled in 1995. The priority date is recommended as February 5, 1996, consistent with the county parcel records and driller report.

Point of Diversion

The claimed point of diversion is located on Ada County parcel R5782850210. The location of the claimed point of diversion is described as Township 5 North, Range 1 West, Section 31, NE¹/₄NW¹/₄.

Source

The source claimed is "groundwater". Well Driller's Report (Drilling Permit No. 63-95-W-0906-000, Well ID: 298289) shows a well was drilled at the claimed POD location. The source is recommended as claimed.

Place of Use

The claimed place of use is located on Ada County parcel R5782850210. The location of the place of use is described as Township 5 North, Range 1 West, Section 31, NE¼NW¼.

According to the Ada County parcel data, Steve and Joanne Love Revocable Trust, owns the property described as the claimed place of use. The place of use is recommended as claimed.

Purpose of Use and Period of Use

The claimed purpose of use is for domestic use for one (1) home and stockwater for 10 horses. In addition to the county data listing a built date of 1996, evidence of a domestic and a secondary structure is visible on available aerial photography. A year-round season of use for domestic and stockwater use is generally recommended if claimed. The season of use for domestic and stockwater use is recommended as claimed.

Quantity

The claimed quantity for domestic use is 0.04 cubic feet per second ("cfs") ¹ and is within the typical range of diversion rates associated with domestic use. The claimed quantity for

stockwater use is 0.02 cfs² and is within the typical range of diversion rates associated with stockwater use. The quantity is recommended as claimed.

CONCLUSION

There is sufficient evidence to recommend water right claim no. 63-35519, as claimed, for domestic and stockwater use. Pursuant to Judge Wildman's *Order Amending Procedures in the SRBA for Adjudication of Deferred De Minimis Stockwater Claims*, dated *October 17, 2017*, the Director submits this Director's Report of Deferred *De Minimis* Domestic and/or Stock Water Use, Claim No. 63-35519, which includes the recommendation of deferred *de minimis* water right no. 63-35519.
