On October 16, 2024, a *Partial Decree Pursuant to I.R.C.P. 54(b)* was issued for the above-captioned water right. On August 21, 2024, the Idaho Department of Water Resources notified this Court of an error in that *Partial Decree*. Upon review of the file the Court finds that the *Partial Decree* contained an error in the description of the Point of Diversion element. The correct Point of Diversion should be "T19N R21E S02 NESWNE." The Court finds this to be the result of a clerical error.

Therefore, IT IS ORDERED that the above-captioned water right is hereby **amended and decreed** as set forth in the attached *Amended Partial Decree Pursuant to I.R.C.P. 54(b)*. The previously issued *Partial Decree* is replaced and superseded thereby.


