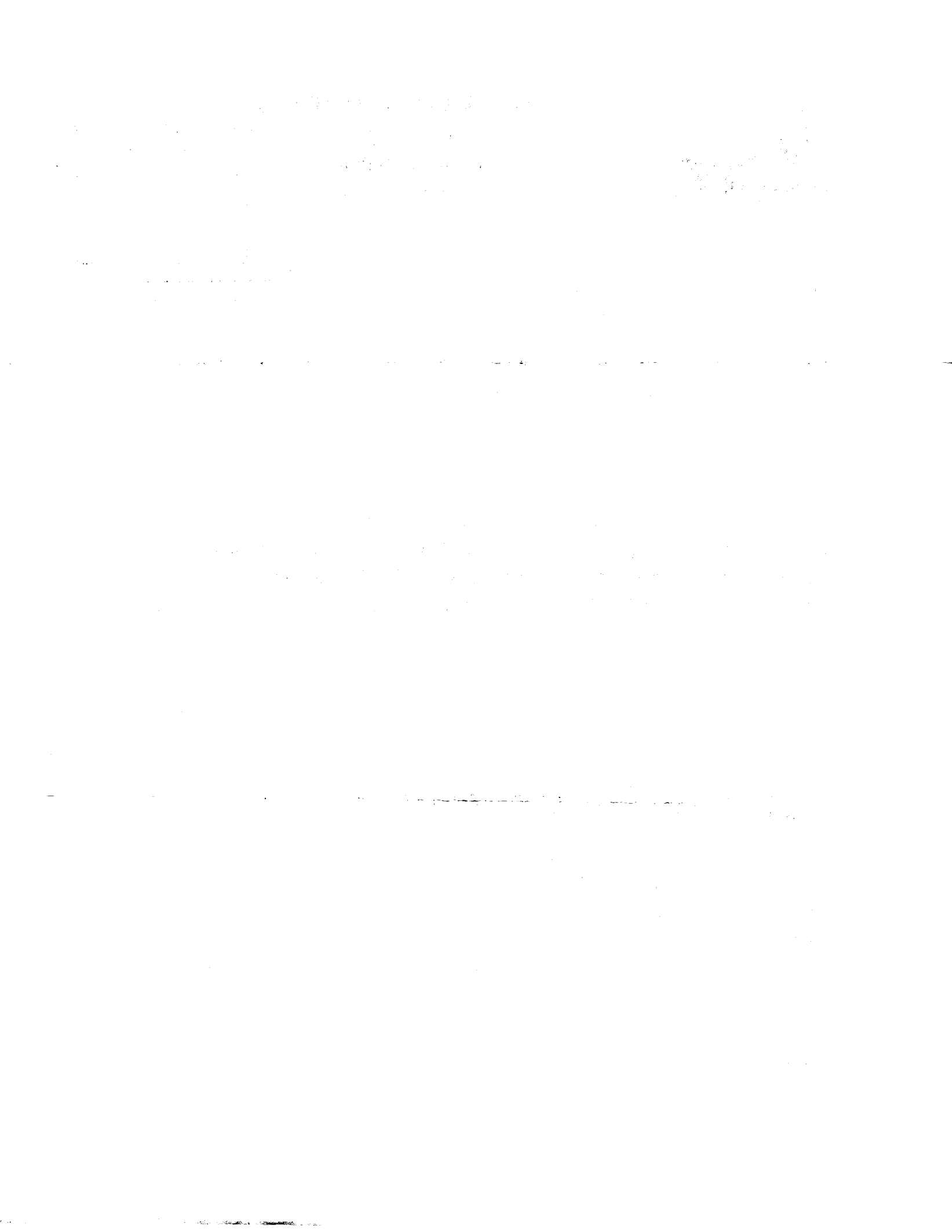

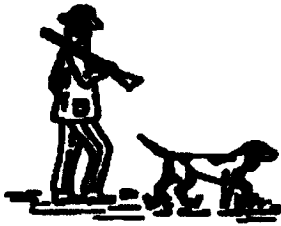
Possibly had you read my packet, instead of revieing it you might have a better understanding of what we have been dealing with IDWRs all these years, and Mr. Hills skullduggery.
