I. PROCEDURAL BACKGROUND

This subcase had a *Response* filed on behalf of Kevin Davis. Later in the litigation process, however, counsel for Mr. Davis filed a *Motion to Withdraw as Counsel*. A hearing on the *Motion* was heard January 15, 2025. Mr. Davis was served with the *Notice of Withdrawal* and the ***Order Setting Hearing***. Mr. Davis did not attend the hearing.


The Court **granted** the *Motion to Withdraw* and required that Mr. Davis either appoint another attorney or notify the Court how he would represent himself in this matter. The Court Order notified Mr. Davis that failure to notify the Court and parties whether and how he would proceed within the 21-day period would be grounds to dismiss his *Response*. ***Order Granting Motion to Withdraw as Counsel*** (January 24, 2025).

Subsequently, Mr. Davis failed to provide notice within the 21-day period how he would proceed in this subcase. The failure to notify the Court and parties how he would proceed constitutes grounds to dismiss the *Response*.

II. FINDING AND CONCLUSIONS

THEREFORE, IT IS ORDERED that the *Response* filed by Kevin Davis in the subcase listed above is hereby **dismissed**.
