- 01:30:11 Court waives use of a court reporter. Proceedings are being recorded on FTR, pursuant to Idaho Administrative Rule 27(b). **Court calls subcase 00-9202169. *Hearing on Motion for Interim Administration.*** Parties identified: Mr. Bromley, Ms. Fischer, Ms. Baser, and Mr. Widerschein are all present. Court gives background/status.
- 01:34:09 Mr. Bromley states that he and Ms. Baser and Ms. Fischer have been attempting to work through the issues, however with no Water Master, they are now out of options and request Court to oversee with Interim Administration.
- 01:35:48 Court asks that since all water rights have been decreed and finalized in the SRBA, does the Court still have authority? Mr. Bromley states that he does not see anything that would prohibit the Court from having authority. Court asks about discussions with IDWR. Mr. Bromley states that they have but that without a Water Master, there is no additional help available.
