Rubelt ("Rubelt"), by and through their attorneys of record, Morrow & Fischer, PLLC, and hereby file this *Unopposed*

**UNOPPOSED MOTION TO WITHDRAW MOTION  
TO ENFORCE SETTLEMENT AGREEMENT**

*Motion to Withdraw Motion to Enforce Settlement Agreement.* Attached herewith is a  
[Proposed] Order Granting Motion to Withdraw Motion to Enforce Settlement Agreement.

On November 29, 2007, a *Motion in Support of Settlement Agreement* was filed by Moonshine, Rubelt, and CRR's predecessor, Harold Evea Powers, in the above-captioned subcases. On March 27, 2024, CRR filed a *Motion to Enforce Settlement Agreement*. On December 20, 2024, proceedings associated with the *Motion to Enforce Settlement Agreement* were effectively stayed while CRR addressed administration of the water rights through a *Motion for Interim Administration*, filed with Judge Wildman in subcase no. 00-92021-69. On April 16, 2025, Judge Wildman issued an *Order Granting Motion for Order of Interim Administration of Water Rights that Divert from Crooked River in Basin 69* ("Order"). Since issuance of the *Order*, staff from the Idaho Department of Water Resources have been discussing administration of the water rights with the parties, with Interim Administration moving forward for the 2025 irrigation season. Pursuant to the *Order*, and if "a water district is not created in time for the 2026 irrigation season, nothing in this Order precludes Crooked River Ranches, LLC from filing a subsequent motion for interim administration for the 2026 irrigation season." *Order* at 3.

On June 24, 2025, the parties appeared before Special Master Booth in the above-captioned subcases, with counsel for CRR orally moving to withdraw the *Motion to Enforce Settlement Agreement*, without prejudice. Counsel for Moonshine and Rubelt did not oppose the oral motion, with the court directing the parties to prepare a written motion to accomplish the withdrawal. Based on the foregoing, the parties hereby move to withdraw the *Motion to Enforce Settlement Agreement*, without prejudice.
