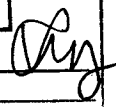

The United States filed an objection in Subcase No. 87-10601 on January 10, 2022, in relation to the August 2, 2021 Director's Report for Basin 87 Water Rights. The United States' objection form (SF1) indicated that the United States filed a competing claim to the same water source, *see* Subcase No. 87-12034.

The United States has acquired additional information about the water source related to these claims. With this information, the United States no longer wishes to maintain, and

now moves to withdraw, this objection.

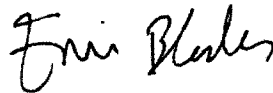

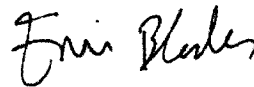
