I, Lacey Rammell-O'Brien, certify and declare under penalty of perjury pursuant to the laws of the State of Idaho, that the following is true and correct:

1. I am over the age of eighteen (18) years and competent to testify to the matters

contained herein. I make this declaration pursuant to Idaho Code § 9-1406 and based on my own

personal knowledge.

2. I am currently a deputy attorney general for the Office of the Attorney General

representing the Idaho Department of Water Resources (IDWR). My work address is 322 E.

Front Street, Boise, ID 83702. I have served in this capacity since June 2021.

3. Pursuant to Idaho Code § 42-1407 and the Court's January 9, 2025, Order Setting Commencement Hearing and Procedures for Hearing and March 27, 2025, Order Granting Joint Motion for Extension, IDWR prepared in plain and concise language an Amended Notice of Filing Petition to Commence General Adjudication of Water Rights (Amended Notice).

4. Pursuant to Idaho Code § 42-1407, IDWR published the *Amended Notice* for three (3) consecutive weeks in a newspaper of general circulation published in each county in which any part of the water system proposed to be adjudicated is located.

5. On June 24, 2025, IDWR deposited the Amended Affidavit of Service for the Amended in U.S. Mail.

6. On June 27, 2025, IDWR filed the *Amended Affidavit of Service* with the Court. Paragraph 10 states that as of the date of the filing, the Department had not received affidavits of publication from the newspapers but would file those with the Court upon receipt.

7. On June 26, 2025, IDWR received the affidavits of publication from the Legal Clerk for Bonner County Daily Bee and Bonners Ferry Herald via U.S. Mail.
