I. PROCEDURAL BACKGROUND

An *Objection* was filed by the United States of America, as trustee on behalf of the Nez Perce Tribe (January 10, 2022). The Nez Perce Tribe filed a joinder to the *Objection*. Subsequently, the United States filed its *United States Motion to Withdraw Objection* (June 4, 2025).

A hearing on the *Motion* was held July 30, 2025. During oral argument, the Nez Perce Tribe joined in the United States' *Motion to Withdraw Objection*. There was no opposition to the *Motion to Withdraw*. The respondent State of Idaho explained that the withdrawal of these *Objections* resolves its *Response*.

II. FINDING AND CONCLUSIONS

THEREFORE, IT IS ORDERED that the Motion to Withdraw Objection is granted for both the United States and the Nez Perce Tribe Objections. The Objections are hereby dismissed with prejudice. Therefore, no Objections remain in this subcase. A Special Master's Report and Recommendation will issue consistent with the Director's Report.
