ORDER AMENDING SRBA

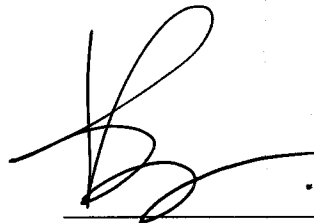
