On January 3, 2025, the State of Idaho filed a Petition pursuant to Idaho Code § 42-1406D for the commencement of a general adjudication inter se of all rights arising under state or federal law to the use of surface and ground water for the Kootenai River basin water system and for the administration of such rights. A hearing on the Petition was held on August 19, 2025. At that hearing, the Court continued the hearing to a date to be determined to consider a Joint Motion to Adopt Proposed De Minimis Procedures filed by the State and the United States on August 18, 2025. The Court in an exercise of its discretion has determined to set the hearing on the State's Petition for November 18, 2025, at 2:00 p.m. (Pacific Time).

THEREFORE, BASED ON THE FOREGOING THE FOLLOWING ARE HEREBY ORDERED:

- 1. The commencement hearing on the State's Petition is set for November 18, 2025, at 2:00 p.m. (Pacific Time) at the Snake River Basin Adjudication Courthouse, 253 3rd Avenue North, Twin Falls, Idaho. This hearing will be conducted using the ZOOM remote hearing application. Instructions for Zoom are attached to this Notice.
- 2. Any response in opposition to the State's Petition shall be filed on or before November 7, 2025.
- 3. Any reply in support of the State's Petition shall be filed on or before November 14, 2025.
