On June 4, 2025, Brian Carpenter and Theresa Carpenter, acting pro se, filed a Motion to File a Claim of Fraud in the SRBA, followed by an Amended Motion to File Claim of Fraud on August 14, 2025. Additionally, on June 20, 2025, the Carpenters filed a Motion to Remove Defendants' Water Rights, Bury Illegal Southwest Ditch, Reinstate Historic Water Delivery, Enjoin Citation, Refer Criminal Violations, and Refer Findings to Lemhi County Civil Court in the SRBA. The Motions filed by the Carpenters pertain to and affect subcase numbers 74-733H and 74-733E. As a result, the Motions should be filed in these individual subcases. However, the Carpenters filed the Motions in SRBA Main Case Number 39576.

As the Carpenters' Motions pertain to and affect subcase numbers 74-733H and 74-733E, the Court finds that those Motions should be filed in those subcases. Therefore, in an exercise of its discretion, and as a housekeeping matter, the Court will order the Clerk of the Court to transfer all documents related to the Carpenters' Motions from the SRBA Main Case into subcase numbers 74-733H and 74-733E. The documents to be transferred shall include all documents filed by Brian Carpenter and Theresa Carpenter, Rockie and LeeAnn Walker, and Joshua McIntosh filed in the SRBA Main Case pertaining to the Carpenters' Motions.

THEREFORE THE FOLLOWING ARE HEREBY ORDERED:

1. The Clerk of the Court forthwith transfer all documents filed by Brian Carpenter and Theresa Carpenter, Rockie and LeeAnn Walker, and Joshua McIntosh in the SRBA Main Case pertaining to the Carpenters' Motions into subcase numbers 74-733H and 74-733E.
2. All further documents filed in this proceeding shall be filed in subcase numbers 74-733H and 74-733E.


