The reason for requesting an extension of the November 20 deadline is that due to the

federal government shutdown the parties have not had sufficient time to coordinate with counsel

for the United States regarding a stipulated process, the parties are still in the process of

presenting the settlement agreement to their respective clients for approval, and additional time is

needed to complete final exhibits for the settlement agreement.

Accordingly, the Coeur d'Alene Tribe respectfully requests that the Court extend the

current deadline to file a stipulated proposed process for effectuating the settlement agreement

from November 20, 2025 to December 30, 2025.
