On June 18, 2025, the Court entered an Order Granting Unopposed Motion to Vacate Trial and Scheduling Deadlines and Reset Trial and Scheduling Deadlines. Among other things, the Order set a trial date to commence in September 2027. On December 30, 2025, the State of Idaho filed an Unopposed Motion to Vacate Trial and Scheduling Deadlines and Reset Trial and Scheduling Deadlines. The Unopposed Motion requests that the trial and scheduling deadlines in this matter be reset as set forth below. The Court in an exercise of its discretion will grant the Unopposed Motion on the basis it is unopposed.

THEREFORE, BASED ON THE FOREGOING, THE FOLLOWING ARE HEREBY ORDERED:

1. The Unopposed Motion to Vacate Trial and Scheduling Deadlines and Reset Trial and Scheduling Deadlines is granted.
2. The parties shall abide by the following litigation schedule:
 - June 22, 2026: Disclosure of Claimants' final expert reports
 - Aug. 17, 2026: Disclosure of Objectors' expert reports
 - Nov. 18, 2026: Disclosure of Claimants' rebuttal reports
 - Jan. 31, 2027: Discovery closes
 - Feb. 20, 2027: Deadline to file dispositive motions
 - May 18, 2027, at 1:30 p.m. (Pacific Time): Status conference

Sept. 1, 2027: Deadline to exchange witness and exhibit lists

Sept. 21, 2027, at 1:30 p.m. (Pacific Time): Initial Pretrial conference

March 2028: Trial
