Motion to Enter Proposed Schedule

On December 9, 2025, the Court held a Status Conference in Subcase 67-15208.¹ The Court set a Status Conference for February 24, 2026, and requested that the parties confer on a mutually agreeable schedule. In advance of that conference, the United States respectfully provides this proposed schedule and moves that the Court enter the schedule for further proceedings.

After the September 2, 2025 Status Conference, undersigned counsel contacted Claimant Gary Gallant by mail with a proposed schedule. No response was received, although Mr. Gallant confirmed at the December 9 status conference that he received the United States' September scheduling proposal. Because it appears unlikely that the parties will reach an agreement on a

trial schedule, in the interest of proceeding to an orderly resolution of the United States'

objection, the United States proposes the following schedule be entered for further proceedings in this matter:

Responses to Dispositive Motions, if any	May 20, 2026
Replies to Dispositive Motions, if any	June 3, 2026
Hearing on Dispositive Motions, if needed (Zoom)	June 24, 2026
Exchange Final Pre-Trial Exhibit and Witness Lists	July 15, 2026
Pre-trial Conference (Zoom)	July 22, 2026
Pre-trial Briefs	July 29, 2026
Trial Begins	First Three Weeks of August – Date To Be Determined ²
