A *Motion to Withdraw as Counsel* was filed by James Browitt on behalf of claimant Linehan Trust on February 17, 2026. A hearing on the *Motion* was held on March 11, 2026.

Mr. Browitt stated that the claimant Linehan Trust does not wish for him to continue to represent it in the above listed subcases. The *Motion to Withdraw as Counsel* was served on the Linehan Trust. The Linehan Trust did not attend the hearing other than through Mr. Browitt.

The Court finds good cause for counsel to withdraw. In addition, the Court finds that the withdrawal will not create delays or prejudice to the parties.

There was no opposition to the *Motion*, and the Court **granted** the *Motion to Withdraw*. Therefore, Mr. Browitt and his firm no longer represent the Linehan Trust in the subcases listed above.

Pursuant to Idaho Rule of Civil Procedure 11.3 (c)(1), IT IS ORDERED THAT:

- 1) Mr. Browitt and his firm are permitted to withdraw as counsel of record for the Linehan Trust.
- 2) Pursuant to IRCP 11.3 (c)(1), the Linehan Trust is **required to appoint another attorney to appear on its behalf in these subcases. This action must be done within 21 days after the Linehan Trust is served with this Order.**

- 3) Pursuant to IRCP 11.3(c)(1), **if the claimant, Linehan Trust fails to file and serve a written appearance explaining how it will proceed within this 21-day period, such failure may be sufficient grounds for dismissing the *Claim*.**
- 4) Mr. Browitt shall serve copies of this order on the Linehan Trust, and shall file proof of service with this Court.
