
On July 18, 2025, a *Motion for Determination of Deferred De Minimis Domestic or Stock Water Use* (Motion) was filed with the Court for water right claim nos. 37-23270, 37-23273, 37-23283, 61-12366, 61-12378, 61-12381, 61-12384, 61-12390, 61-12392, 61-12405, 61-12407, 61-12536, 63-35004, 63-35007, 63-35010, 63-35011, 63-35012, 63-35013, 63-35014, 63-35015, 63-35016, 63-35018, and 63-35019.

The Idaho Department of Water Resources (IDWR) has published the notice of the Motions and no objections to the claims have been filed. The Director of IDWR:

- Will not conduct an examination of the claim
- Will conduct an examination of each claim and file a report with the district court on or by **May 4, 2027**.
- Will commence an examination of the water system pursuant to Idaho Code § 42-1410 (2003) and file a report on its findings with the district court on or by \_\_\_\_\_.
