On March 24, 2026, a *Special Master's Report and Recommendation* was filed for the above water right claim, recommending said water right claim not be decreed and the claim be dismissed. No challenges were filed to the *Special Master's Report and Recommendation* and the time for filing challenges has expired.

Pursuant to I.R.C.P. 53(j), and *PRBA Administrative Order 1*, Section 19(c), this Court has reviewed the Findings of Fact and Conclusions of Law contained in the *Special Master's Report and Recommendation* and wholly adopts them as its own.

Therefore, IT IS ORDERED that the above water right claim is hereby **disallowed with prejudice** and shall not be confirmed in any partial decree or in any final decree entered in the PRBA, Case No. 59576, in whatever form that final decree may take or be styled.
