HAC VICE**

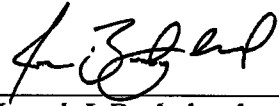

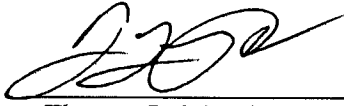

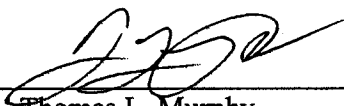
