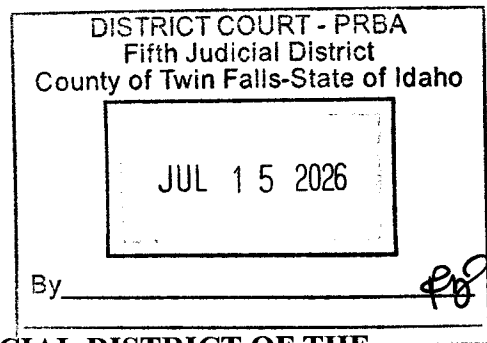

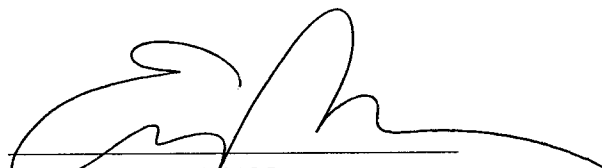

**ORDER AMENDING ORDER
ADMITTING COUNSEL PRO HAC

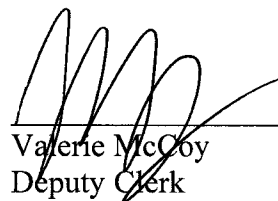
