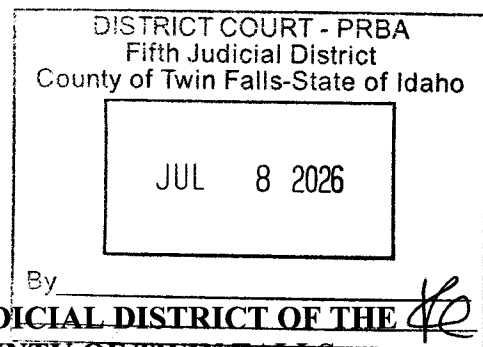

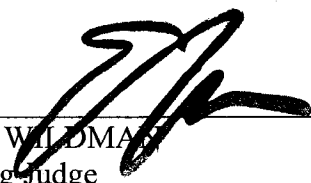

) **ORDER OF PARTIAL DECREE FOR**
) **GENERAL PROVISION IN BASIN 87**
)

On August 2, 2021, the Director of the Idaho Department of Water Resources filed a *Director's Report for Basin 87*, which included a recommendation for a general provision. An objection to the recommendation was filed by the City of Moscow. The objection was resolved by the filing of a *Standard Form 5* on March 6, 2023. In the *Standard Form 5*, the parties agreed that there should be no general provisions in Basin 87. On May 29, 2026, the Special Master entered a *Special Master's Report and Recommendation*, recommending that there shall be no general provisions in Basin 87 consistent with the *Standard Form 5*. No Challenges were filed to the *Special Master's Report and Recommendation* and the time for filing Challenges has now expired.

Pursuant to I.R.C.P. 53(j), this Court has reviewed the findings of fact and conclusions of law contained in the *Special Master's Report and Recommendation* and wholly adopts them as its own.

Therefore, IT IS ORDERED that there shall be no general provisions in Basin 87 as set forth in the attached.
