The quantity under this water right is limited to up to 1.000 acre feet per year, with a diversion rate never to exceed the lesser of 1.00 CFS or twenty-five (25) percent of the rate of flow then available at each point of diversion and, cumulatively, no more than twenty-five (25) percent at the furthest downstream point of diversion in use under water right nos. 92-11067A thru 92-11075 and 92-11080A thru 92-11081D.

PLACE OF USE: National Forest System Land in the Carlin Creek-St Maries River subwatershed (HUC12 170103041005), Lower Santa Creek subwatershed (HUC12 170103040903), Rochat Creek-St Joe River subwatershed (HUC12 170103040609), Thorn Creek subwatershed (HUC12 170103041004), Beaver Creek-St Maries River subwatershed (HUC12 170103041001), John Creek subwatershed (HUC12 170103041002), Alder Creek subwatershed (HUC12 170103041003), Benewah Creek subwatershed (HUC12 170103041102) and Pedee Creek-St Joe River subwatershed (HUC12 170103041104).

OTHER PROVISIONS NECESSARY FOR DEFINITION OR ADMINISTRATION OF THIS WATER RIGHT:

This right is limited to the intermittent diversion and use of water for the stated purposes. This water right shall not be used as a basis to prevent the future appropriation of water or the basis to request or initiate a delivery call or otherwise have the Idaho Department of Water Resources, a Water District or a Court curtail or limit distribution in whole or in part, to existing legal uses of water to satisfy this water right. This provision shall not be construed as a basis to curtail the United States' use of water under this right to satisfy junior water rights.

This partial decree is subject to such general provisions necessary for the definition of the rights or for the efficient administration of the water rights as may be ultimately determined by the Court at a point in time no later than entry of a final unified decree. Idaho Code § 42-1412(6).
